1、本系總畢業學分數至少72學分：

1、The minimum graduation credit requirement for the department is 72 credits:

(1)選修通識課程(人文與藝術類、社會科學類、自然科學類與創意跨域類)，每類選修0-2學分，合計6學分，超過之學分數不得計入系訂選修學分。

(1) Elective general education courses (0-2 credits each from Humanities and Arts, Social Sciences, Natural Sciences, and Creative Interdisciplinary categories, for a total of 6 credits). Exceeding credits cannot be counted toward the elective credits required by the department.

(2)系訂專業必修課程33學分。

(2)The required major courses in the department amount to 33 credits.

(3)專業選修課程至少33學分，其中系訂專業選修課程至少22學分(含學院選修課程)；專業選修學分不含通識課程學分。

(3)A minimum of 33 credits in professional elective courses, with at least 22 credits in department-specific professional electives (including college-specific electives); professional elective credits do not include general education credits.

2、每學期修業學分數：第1學年12-25學分，第2學年9-25學分。

Credits per semester: 16-25 credits in the first and second academic years, 12-25 credits in the third year, and 9-25 credits in the fourth year.

3、請勿重複修習已修習過之課程或未經核准上修本系課程，否則該課程不予認列為畢業學分數。

Please refrain from retaking courses already completed or enrolling in advanced departmental courses without approval. Credits earned from such courses will not be counted toward graduation requirements.

(3)Pass the department-specific information technology competency test. Related regulations can be found in "Enforcement Rules for Information Technology Licensing Tests."

(4)通過校訂「學術倫理教育」課程，相關規定請參照本校「學術倫理教育課程實施要點」。

(4)Complete the CLUT-mandated "Academic Ethics Education" course, as outlined in the "Academic Ethics Education Program Implementation Requirements".
